Portfolio Commentary

During February 2014 Cadence Cayman Fund returned a positive net performance of 2.80% compared to an increase in the All Ordinaries Accumulation Index of 4.84%. For the past 50 months the fund has returned an annualized positive net performance of +17.18% per annum compared to an increase in the All Ordinaries Accumulation Index of +7.01% per annum.

The fund finished the month 86.19% net long. The net exposure for January 2014 was 86.39%.

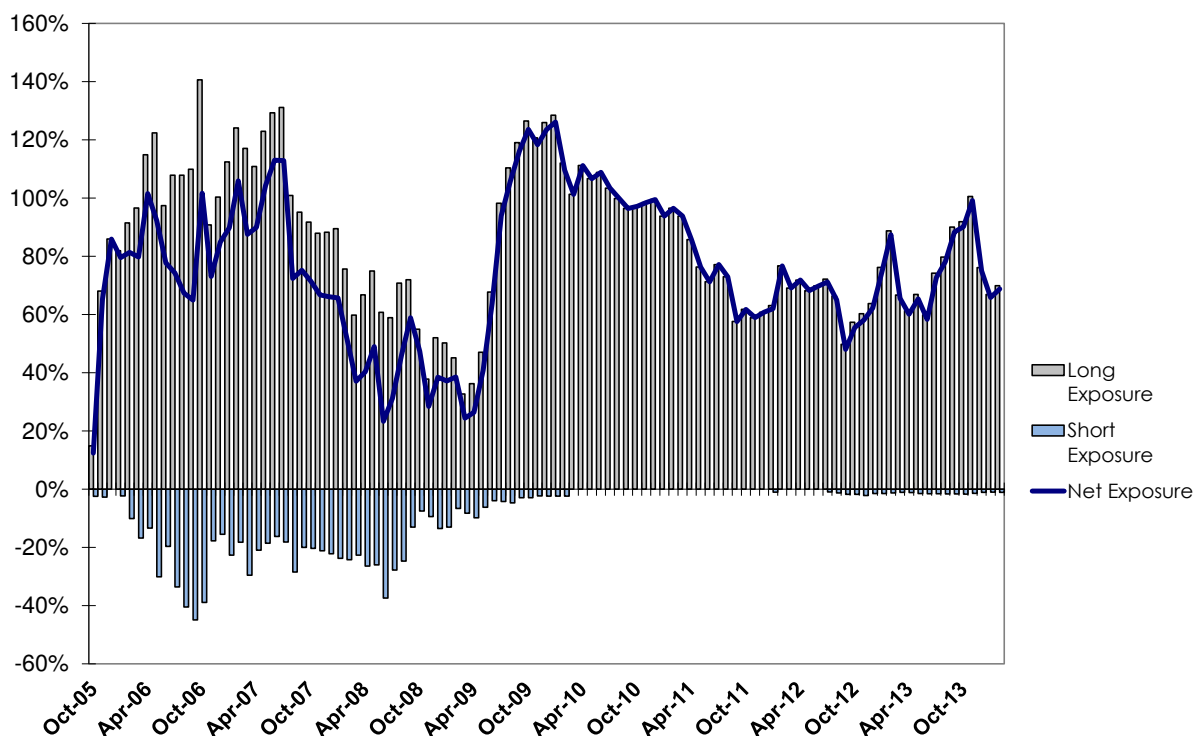
Historic Strategy Performance & Exposure - 8 Years
