

For the month of March 2019, Cadence Capital Fund returned a negative gross performance of 2.4%, compared to an increase in the All Ordinaries Accumulation Index of 0.7%.

As at 31 March 2019, the fund is 83.5% invested (16.5% cash).

For the month, the largest contributor to the Company's performance was Shine Corporate and the largest detractors from performance were Emeco Holdings, Money3 Corporation and Seven Group. 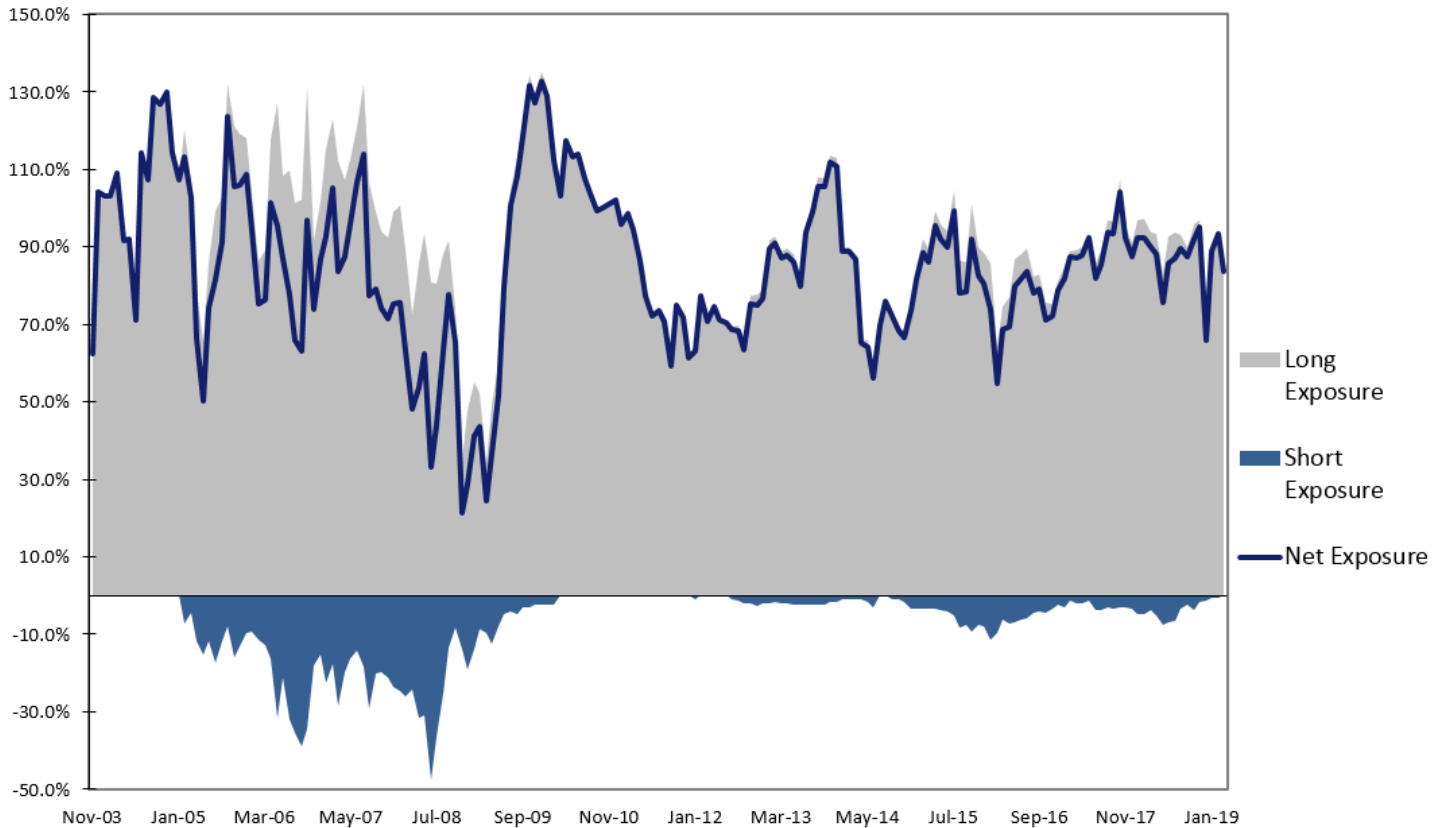
